

Your designated Catholic secondary school is now accepting applications for admission to Year 7 in 2018. You are kindly requested to complete the accompanying application form for the enrolment of your son or daughter and return it **within a week** of receiving it. Increasingly, schools are finding difficulty in accepting all requests for enrolment, therefore early return of your application is important. If limits on class sizes have to be imposed, **late applications may, unfortunately, have to be added to the waiting list or declined.**

Completed applications are considered carefully and you will be informed as quickly as possible regarding acceptance. Finalisation of school fee payments in previous diocesan schools is a condition of enrolment in another diocesan school.

Catholic schools offer a unique educational experience which forms the young person as a person of integrity, compassion, faith and wisdom. Catholic schools also work closely with their local parish to enhance in students a capacity to make sense of their world, to make judgements and to recognise the uniqueness of others within a faith community. Above all, they offer a comprehensive religious education program. Catholic schools don't just teach religious studies, they seek to develop spirit, mind, body and character and cultivate Gospel values that support lives filled with joy, endeavour and hope in the future.

SCHOOL FEES

Catholic schools are typically seen as great value for money. Catholic schools do more with less whilst still providing high-quality education supported by quality facilities and learning environments. Each school year the Catholic Diocese of Maitland-Newcastle, through its agency the Catholic Schools Office, reviews the fees for students in our diocesan schools for the coming year. By far the greater part of our schools' funding now comes from State and Commonwealth government grants, but the commitment and continuing financial contribution of parents and parish communities is still essential to fill the gap between the funds provided by government and the actual cost of running our schools.

School fees in the diocese are made up of a number of charges

1. Diocesan tuition fees
2. Individual school resource and service fees
3. Diocesan Family School Building Levy (DFSBL)

Diocesan tuition fees

These are set each year by the Bishop. In 2017 the full rate diocesan tuition fees are:

- Kinder to Year 6 \$ 1,206
- Years 7 to 10 \$ 1,662
- Years 11 to 12 \$ 2,502

In 2017, the family discount on full rate diocesan tuition fees are:

- 1 child family 0% - full rate to be applied
- 2 child family 10% - each child
- 3 child family 20% - each child
- 4 child family 40% - each child
- 5+ child family 50% - each child

Individual school resource and service fees

These are fees set by individual schools and can cover a range of costs including the supply of resources such as texts, school supplies, exercise books, subject levies, technology, excursion costs etc. The cost and nature of the fees can vary between schools and they will be set out in the parent handbook provided by the school and itemised in the school fee account from the school.

Diocesan Family School Building Levy (DFSBL)

The DFSBL is charged to the oldest child for each family. The levy is pooled to contribute towards past, present and future costs for building projects across all existing and for new Catholic schools, and the acquisition of land for school purposes.

The DFSBL rate for 2017 will be \$600 per family. The DFSBL rate is reviewed, recommended and approved in the same manner as mentioned earlier for the tuition fees and discounts.

Diocesan pastoral contribution

From 2017 a voluntary contribution of \$150 per family (\$50 per term) is being sought as a diocesan pastoral contribution. Funds support the ongoing pastoral works of the diocese which include, amongst many initiatives:

- The diocesan pastoral ministries office and the activities of its many advisory councils - the Diocesan Pastoral Council, the Adult Faith Formation Council, the Liturgy Council, the Ecumenical and Interfaith Council, the Social Justice Council and the Diocesan Council of Ministry with Young People.
- The provision of chaplains ministering in the following areas – Newcastle University, Newcastle Port, Prisons, Hospitals and Catholic Care Social Services.
- Family Community Faith Coordinators who work to reach out to and connect families with their local parish and school.
- Pastoral Coordinators who work in those parishes without a resident Parish Priest.

Enrolment Fee

This fee is payable upon confirmation of enrolment. This fee is generally non-refundable and is payable before the student commences school. The enrolment fee covers all administrative work involved in processing the application.

SPECIAL FEE REDUCTIONS

To assist families with limited financial resources, Catholic schools in the Diocese of Maitland-Newcastle offer a lower tuition fee to means tested low income families such as Health Care and Pension Card holders. This rate is 50% of the diocesan tuition fee full rate for each child. This discount applies only to the diocesan tuition fee, not to the DFSBL or other resource and service fees charged by each individual school.

It is the policy of the Catholic Schools Office and the Diocese that financial hardship should not prevent any child from attending a Catholic school and no child will be denied a Catholic education because of a family's genuine inability to pay the required school fees. Any family experiencing financial difficulties is entitled to fee assistance; your local school Principal will be able to discuss this with you.

Together with parents, clergy and school staff, we are committed to offering the children in this diocese access to schools in which their faith can be nurtured in outstanding learning environments. We seek to assist young people to realise their full human potential, taking into account their unique spiritual, intellectual, physical and social needs. We value the opportunity to work in partnership with you, and thank you for your continuing support of Catholic education in this Diocese.

Payment Methods

Various options are available for payment of fees. These include periodic payments, BPAY, direct debit and credit card. Parents wishing to pay by periodic instalments are requested to nominate their payment method on the 1st account sent home at the beginning of the year.

All fees must be paid in full by the commencement of Term 4.

Billing Cycle

School fees are billed over the first three terms of the school year. However you may prefer to pay yearly. Other schedules of payment can be negotiated with the school principal or school finance officer.

ENROLMENT BOUNDARIES

Each secondary school caters for students from a group of parishes in the Diocese. The enrolment boundaries are of particular importance in the Newcastle and Maitland areas where there are several secondary schools. Enrolment boundaries in these two areas has enabled us to achieve equitable class loads in all schools and thus an improved educational situation.

In the past, parents have been most co-operative with regard enrolment boundaries. Requests for admission to a school outside the student's catchment must be accompanied by written details of the particular educational, pastoral or family needs which can be best met by the out-of-area school. Such requests will be considered initially by the school for which the child is designated.

ST. JOSEPH'S HIGH SCHOOL, ABERDEEN

Accepts students, Years 7-12, from the areas of Denman, Merriwa, Muswellbrook Scone and Murrurundi.

ST. PIUS X HIGH SCHOOL, ADAMSTOWN

Accepts students, Years 7-10, from the areas of Adamstown, Broadmeadow, Hamilton, Kotara South, Lambton, Newcastle, New Lambton, Wallsend and Shortland and defined by the feeder primary schools.

ST. PAUL'S HIGH SCHOOL, BOORAGUL

Accepts students, Years 7-12, from the areas of Boolaroo-Warners Bay, Cardiff, Glendale/West Wallsend, Morisset, Toronto, Booragul and defined by the feeder primary schools.

ST. BEDE'S CATHOLIC COLLEGE, CHISHOLM

Accepts students, Years 7-12, from the areas of Berry Park, Chisholm, Duckenfield, Hinton, Morpeth, Phoenix Park, Raworth (partial), Thornton, Beresfield, Tarro and Woodberry and defined by the feeder primary schools.

ST. MARY'S CATHOLIC COLLEGE, GATESHEAD

Accepts students, Years 7-12, from the areas of Belmont, Boolaroo-Warners Bay, Charlestown, Gateshead, Windale and Swansea and defined by the feeder primary schools..

ST. FRANCIS XAVIER'S COLLEGE, HAMILTON

Accepts students, Year 11 and 12 from Year 10, St. Pius X High School, Adamstown, Year 10, St. Mary's High School, Gateshead, and Year 10, San Clemente High School, Mayfield.

ST. JOSEPH'S COLLEGE, LOCHINVAR

Accepts students, Years 7-12, from the areas of Branxton (where transport to Lochinvar is more convenient than it is to Singleton), Cessnock, Lochinvar and Rutherford*.

ALL SAINTS' COLLEGE, ST. MARY'S CAMPUS, MAITLAND

Accepts students, Years 11-12, from the areas of Dungog, Gresford, East Maitland, Kurri Kurri, Maitland, Lochinvar and Rutherford

ALL SAINTS' COLLEGE, ST. PETER'S CAMPUS, MAITLAND

Accepts students, Years 7-10, from the areas of Dungog, Gresford, East Maitland, Kurri Kurri, Maitland Raworth (partial) and Rutherford. The geographic boundary for Raymond Terrace is west of the Hunter River.

SAN CLEMENTE HIGH SCHOOL, MAYFIELD

Accepts students, Years 7-10, from the areas of Mayfield/ Mayfield West, Nelson Bay, Raymond Terrace, Stockton, Wallsend/Shortland and Waratah. The geographic boundary for Raymond Terrace is east of the Hunter River.

ST. CATHERINE'S CATHOLIC COLLEGE, SINGLETON

Accepts students, Years 7-12, from the parishes of Branxton (where transport to Singleton is more convenient than it is to Lochinvar) and Singleton

ST. CLARE'S HIGH SCHOOL, TAREE

Years 7-12, from the areas of Bulahdelah, Forster- Tuncurry, Gloucester/Krambach, Taree and Wingham
